I/We, , do hereby make this legally binding release, waiver and assumption of risk to the Wagging Dog Rescue (WDR). I/We wish to participate in the above requested Meeting on the date indicated and I/we hereby agree as follows:

- 1. I/We acknowledge and understand that as part of my/our participation in this Meeting during the present Coronavirus (COVID-19) outbreak in Southern California, there are dangers, hazards and inherent risks to which I/we may be exposed, including the risk of serious illness and death, as well as economic and other loss. The dangers, hazards and risks may arise from my/our own actions, inactions, or negligence as well as from the actions, inactions or negligence of others, or the condition of the premises. I/We also acknowledge and understand that there may be other dangers, hazards or risks not presently known or reasonably foreseeable. Participation in the Meeting may include travel to and from the Meeting.
- 2. I/We agree to adhere to all current safety recommendations for public engagement and activity during the Coronavirus outbreak in Southern California, as well as all jurisdictional laws and ordinances, laws of the State of California and of the United States government. This includes maintaining a No Touch policy with a minimum six (6) foot social distance between myself and all other human participants not of my immediate household. If I/we fail to adhere to the above-referenced policies, procedures, and/or ordinances and laws, I/we will be responsible for any injuries and/or damages that may result. Further, if I/we fail to adhere to the above-referenced policies, procedures, and/or ordinances and laws, this failure may result in my/our immediate dismissal from the Meeting.
- 3. I/We affirm that we have not experienced any of the following symptoms of COVID-19 at any time in the last seventeen (17) days: fever, tiredness, dry cough, difficulty breathing.
- 4. I/We understand that if I/we have any underlying health conditions, known or unknown, I/we may be more vulnerable of becoming severely or fatally ill if I/we contract COVID-19.
- 5. I/We understand that WDR has taken all necessary processes to sterilize all dog/cat handling equipment that may pass between Meeting participants but that the Wagging Dog Rescue can not guarantee the safety and security of any items used during the Meeting.
- 6. I/We understand that as of August 24, 2020 per the Centers for Disease Control and Prevention (CDC) website, the risk of animals spreading COVID-19 to people is considered to be low, however it appears that it can spread from people to animals in some situations, and more studies are needed to understand if and how different animals could be affected by COVID-19.
- 7. I/We agree to assume all dangers, hazards and risks arising from my/our participation in the Meeting and do hereby hold harmless and agree to indemnify the Wagging Dog Rescue, and its Directors and/or volunteers, from any and all claims, causes of action, damages, illness and/or liabilities arising out of or resulting from my/our participation in the Meeting. This agreement is binding on my heirs and assigns.
